- **Linking Words:**

The words written on the arrows are just as important as the concepts

themselves.

Instead of a generic arrow, use phrases like "is converted into," "requires the enzyme," "allosterically inhibits," or "provides substrate for." This specifies the nature of the relationship.

- **Examples:**

Adding specific examples at the bottom of the map (e.g., "Glucose-6-phosphate" as an example of a phosphorylated sugar) grounds the abstract concepts in concrete reality.

Review your list. Identify the one or two

most inclusive concepts. For glycolysis, this might be "Glycolysis" itself or "Carbohydrate Catabolism." Place these at the top of your workspace. Next, rank the remaining concepts in order of specificity. "ATP" might be fairly general, while "2-Phosphoglycerate" is very specific.

Step 3: Build the Preliminary Map

Using a large sheet of paper, a whiteboard, or a digital tool, start arranging your concepts from top to bottom. Connect them with arrows and add linking words. For

example, you might write "Glucose" connected by an arrow labeled "is phosphorylated by" to "Glucose-6-phosphate." Do not be afraid to rearrange items multiple times. The process of shuffling and connecting is where most of the learning happens.

Step 4: Establish Cross-Links

Once the main hierarchical structure is in place, look for connections between different branches of the map. For instance, note how "Fructose-2,6-bisphosphate" (a

regulatory molecule) connects to "Phosphofructokinase-1" (an enzyme). Add these cross-links carefully, as they often represent the most nuanced and clinically relevant insights.

Step 5: Revise and Refine

A concept map is never truly "finished." As you study more, you will find better linking words, discover missing concepts, or realize that the hierarchy can be improved. Set your map aside and revisit it after a day. Try explaining the map to a peer. Revising the

map deepens your memory and corrects any misconceptions.
