jurisdictional research with content from the UK, EU, and other regions.

Each plan has a different price point, with Westlaw Edge being the most expensive due to its proprietary AI and analytical tools.

2. Organizational Scale

The number of users in your organization dramatically affects the per-user cost. Large law firms often negotiate enterprise agreements with flat annual fees, while solo practitioners pay per

attorney.

- **Solo Practitioners:** Typically pay a fixed monthly or annual fee per attorney, with limited concurrent users.
- **Small to Mid-Size Firms:** Often receive a firm-wide flat rate based on the number of attorneys and anticipated usage.
- **Large Enterprises:** Negotiate custom contracts that include unlimited usage, premium support, and access to specialized databases.

Transaction vs. Subscription Billing

Historically, Westlaw charged per query or per document viewed, a model that could lead to unpredictable bills. Today, most users prefer subscription billing, which provides predictable monthly costs. However, some transactional plans still exist for occasional users.

- **Subscription Plans:** Fixed monthly or annual fee for unlimited research within

defined content sets. Best for high-volume researchers.

- **Transactional Plans:** Pay-as-you-go model, often with a meter running for each search or document access. Best for very light or sporadic use.
- **Blended Plans:** A base subscription with a transaction allowance for additional databases not included in the base plan.

WESTLAW PRICING FOR LAW STUDENTS AND ACADEMICS

Law students are a major demographic for Westlaw, and the

pricing for this group is structured very differently from professional plans.

Student Access

Most law schools provide free, unlimited access to Westlaw for enrolled students through the law school's institutional subscription. This access is restricted to educational use only and ends upon graduation or bar passage. Students pay nothing out-of-pocket for this access.

Graduate and Bar

Prep Plans

Once a student graduates, they lose the free educational access. Thomson Reuters offers special transitional pricing for recent graduates studying for the bar exam. These plans are typically deeply discounted for a 6-12 month period and provide access to study aids, practice questions, and bar-specific content. Prices for these plans range from \$50 to \$150 per month, depending on the content package.

WESTLAW PRICING FOR SOLO PRACTITIONERS AND SMALL FIRMS

For independent attorneys and small

firms, cost is a critical factor. Westlaw offers several packages tailored to smaller practices. While exact pricing is not publicly listed, based on industry reports and user testimonials, here is an approximate range:

- **Basic Primary Law Plan:** Ideal for solo practitioners who only need state and federal statutes and case law. Estimated cost: \$150–\$350 per month per attorney.
