## **UNDERSTANDING THE FORT SILL LEVY BRIEF: A COMPLETE GUIDE FOR SERVICE MEMBERS AND FAMILIES**

For soldiers stationed at Fort Sill, Oklahoma, few administrative processes carry as much weight as the Fort Sill Levy Brief. Whether you are preparing for a permanent change of station (PCS), deployment, or a temporary duty assignment, the levy brief serves as a

# Sill Levy Brief?

A Fort Sill Levy Brief is an official military briefing that informs soldiers about an upcoming assignment, deployment, or change of duty station. The term "levy" refers to the allocation of personnel to meet operational requirements. At Fort Sill, which is home to the U.S. Army Field Artillery School and multiple operational units, levy briefs are a routine but essential part of personnel management.

During the briefing, soldiers receive detailed information about their new assignment, including location, reporting date, transportation options, and family support resources. The brief also covers administrative requirements such as medical readiness, finance updates, and

legal considerations. While the format may vary slightly by unit, the core purpose remains consistent: to ensure soldiers are fully prepared for their upcoming move.

## The Purpose and Importance of the Levy Brief

The Army places a high priority on readiness, and the levy brief is one of the key tools used to maintain it. By centralizing critical information in a single session, the brief helps reduce confusion, minimize delays, and prevent last-minute issues that could affect a

soldier's ability to report on time. Several key objectives are achieved through the Fort Sill Levy Brief:

- **Mission Readiness:** Ensuring soldiers are physically, mentally, and administratively prepared for their next assignment.
- **Family Support:** Providing information about resources available to military families during a PCS or deployment.
- **Regulatory Compliance:** Meeting Army requirements for out-processing and transfer of personnel.
- **Career Continuity:** Helping soldiers understand how the new assignment fits into their long-term career progression.

For soldiers who attend the brief without adequate preparation, the experience can feel overwhelming. However, those who arrive with questions and a proactive mindset tend to leave with a clear roadmap for the weeks ahead.

## Who Needs to Attend the Fort Sill Levy Brief?

Attendance at the Fort Sill Levy Brief is typically mandatory for all soldiers who have received assignment instructions, deployment orders, or PCS notification while stationed at Fort Sill. This includes:

- Active duty soldiers moving to a

- new duty station
- Soldiers deploying in support of overseas operations
- Reserve and National Guard personnel on active duty orders
- Soldiers transitioning to a different unit within Fort Sill

In some cases, family members may also be encouraged or required to attend portions of the brief, particularly those covering relocation benefits, medical coverage, and school enrollment for dependents.

## When and Where

## Does the Brief Take Place?

The Fort Sill Levy Brief is held at designated locations on post, often in a classroom or auditorium setting. The briefing schedule varies by unit, but most occur on a recurring basis, such as weekly or biweekly. Soldiers are usually notified of the date and time by their unit's S1 (personnel) shop or their first-line supervisor.

It is important to note that the levy brief is not a one-time event. Depending on the complexity of the assignment, soldiers may be required to attend multiple sessions, especially if they are deploying or moving to an overseas

location with additional requirements.

## Key Topics Covered During the Brief

A comprehensive Fort Sill Levy Brief covers a wide range of topics designed to address every aspect of the upcoming move. Below is a breakdown of the most common subject areas:

### **ADMINISTRATIVE PROCESSING**

This section covers paperwork requirements, including DA Forms, leave and earnings statements, and personnel file updates. Soldiers are advised to

verify that their records are current and accurate before the brief.

### **TRANSPORTATION AND HOUSEHOLD GOODS**

Information about moving household goods, shipping vehicles, and arranging travel is provided. Soldiers learn about the Defense Personal Property System (DPS) and how to schedule a move. Weight allowances, restricted items, and storage options are also discussed.

### **MEDICAL AND DENTAL READINESS**

Medical readiness is a top priority. Soldiers must ensure their immunizations are current, dental exams are completed, and any pending medical issues are resolved. The brief explains

how to access medical records and schedule appointments before departure.

### **FINANCE AND PAY**

Finance topics include per diem rates, travel advances, temporary lodging expense reimbursement, and how to update direct deposit information. Soldiers also learn about entitlements such as dislocation allowance and family separation pay.

### **HOUSING AND FAMILY SUPPORT**

For soldiers with families, housing options at the new duty station are covered. The brief also highlights support services such as the Army Community Service (ACS), family

advocacy programs, and school liaison services.

### **LEGAL AND ADMINISTRATIVE MATTERS**

Legal topics include powers of attorney, wills, and dependent care plans. Soldiers are encouraged to update their legal documents before departing, especially if deploying or moving overseas.

### **CAREER AND EDUCATION RESOURCES**

The brief may also cover educational opportunities, such as using tuition assistance during the assignment or transferring GI Bill benefits to dependents. Career counselors are often available to answer questions.

# How to Prepare for the Fort Sill Levy Brief

Preparation is the key to a smooth levy brief experience. Soldiers who arrive prepared can focus on the information presented rather than scrambling to gather missing documents. Here are some practical steps to take before attending:

1. **Review your assignment instructions** carefully, noting the reporting date, location, and any special requirements.
2. **Ensure your medical and**

**dental records** are up to date.

Schedule any needed appointments well in advance.

3. **Verify your personnel file** through iPERMS or your unit S1. Correct any errors before the brief.
4. **Gather important documents** such as your ID card, marriage certificate, children's birth certificates, and vehicle title.
5. **Prepare a list of questions** specific to your situation, whether it involves housing, schools, or pet transportation.
6. **Inform your family** about the briefing schedule and any sessions they may need to attend.

# Common Challenges and How to Overcome Them

Even with careful preparation, soldiers may encounter challenges during the Fort Sill Levy Brief process. Some of the most common issues include:

- **Incomplete Records:** Missing or outdated documents can delay processing. Solution: Check your records early and address discrepancies immediately.

- **Family Concerns:** Spouses and children may feel anxious about the move. Solution: Attend family support sessions and use resources like ACS for guidance.

# The Role of the Unit in Supporting the Levy Process

While the Fort Sill Levy Brief is a centralized event, the soldier's unit plays a vital role in ensuring a successful transition. First-line supervisors should review the soldier's readiness status before the brief and provide any necessary guidance. Unit S1 personnel can assist with administrative tasks, and the unit's master driver or training NCO may need to update specific

qualifications.

A team approach between the soldier, the unit, and the briefing staff helps create a seamless experience. Soldiers should not hesitate to reach out to their chain of command with questions or concerns.

## Post-Brief Actions: What Comes Next?

After attending the Fort Sill Levy Brief, soldiers must complete a series of follow-up actions. These typically include:

- Scheduling a final medical and dental check
- Confirming travel arrangements and household goods pickup
- Completing any outstanding online training or courses
- Clearing post facilities such as the library, gym, and supply room
