## DEFINING THE THREE STATES OF MIXTURES

# What is a True Solution?

A **solution** is a homogeneous mixture where one substance (the solute) is completely dissolved in another (the solvent). The key here is the particle size. In a true solution, the solute particles are incredibly small, typically less than 1 nanometer (nm) in diameter. These particles are individual molecules or ions. Because they are so tiny, they do not scatter light and cannot be seen under a microscope. They will not settle out over time and cannot be separated by ordinary filtration. Common examples include sugar dissolved in water, air (a mixture of gases), and alloys like brass.

# What is a Sol (Colloidal Solution)?

The term "**sol**" is short for a solid-in-liquid colloid. A colloid is a mixture that sits between a true solution and a suspension. The dispersed particles in a colloid are larger than those in a solution but smaller than those in a suspension. They typically range from 1 nm to 1000 nm (or 1 micrometer). These particles are not individual molecules but rather clusters of molecules. A sol is a specific type of colloid where solid particles are dispersed throughout a liquid medium. The most famous example of a sol is

milk (where fat and protein particles are dispersed in water). Other examples include ink, blood, and paint. Unlike solutions, the particles in a sol are large enough to scatter light, a phenomenon known as the Tyndall effect.

# What is a Suspension?

A **suspension** is a heterogeneous mixture where large, visible particles are dispersed throughout a liquid or gas. The particle size in a suspension is greater than 1000 nm (1 micrometer). These particles are large enough to be seen with the naked eye or a low-power microscope. Because they are so large and heavy, they will eventually settle out

of the mixture under the influence of gravity. Suspensions are also cloudy or opaque and can often be separated by simple filtration. Classic examples include muddy water, sand in water, and dust particles in the air.

### THE CORE DIFFERENCES: HOW ARE SOL SOLUTION AND SUSPENSION DIFFERENT?

---

Now that we have the basic definitions, we can systematically compare them. The differences are profound and are best understood by examining several key properties.

## Particle Size: The Defining Factor

This is the most fundamental distinction. The size of the dispersed particles dictates every other property.

- **Solution:** Particles are less than 1 nm in diameter. They are the size of atoms or small molecules.
- **Sol (Colloid):** Particles are between 1 nm and 1000 nm. They are multi-molecular clusters.
- **Suspension:** Particles are greater than 1000 nm. They are macroscopic and visible.

Think of it like a scale of visibility: solutions are invisible at the particle

level, colloids are a twilight zone of tiny but detectable particles, and suspensions are the world of visible grains and droplets.

## Homogeneity: Are They Uniform or Not?

The particle size directly impacts how uniform the mixture appears to be.

- **Solution:** Truly **homogeneous**. You cannot distinguish the solute from the solvent, even with a powerful microscope. Every sample of a true solution has the exact same composition.

- **Sol (Colloid):** Appears **homogeneous** to the naked eye but is actually **heterogeneous** at the microscopic level. It is a uniform dispersion of distinct particles.
- **Suspension:** Visibly **heterogeneous**. You can see the different components, like sand grains floating in water.

## Stability and Settling: Will It Last?

This is one of the most practical ways to tell them apart.

- **Solution:** Perfectly **stable**. The solute particles are so small and have such a strong interaction with the solvent that they will never settle out, no matter how long you wait.
- **Sol (Colloid): Stable** but not permanent. The particles are small enough that they do not settle quickly due to Brownian motion (random collisions with solvent molecules). However, they can be made to settle through processes like centrifugation or by adding an electrolyte to coagulate them.
- **Suspension: Unstable.** The large particles are heavy and will rapidly settle to the bottom due to gravity. You have to shake a suspension (like a bottle of orange juice with

pulp) to temporarily re-disperse the particles.

## Visibility and Light Scattering: The Tyndall Effect

This is a classic experiment to distinguish a solution from a colloid.

- **Solution:** Does **not** scatter light. A beam of light passing through a solution is invisible (the path is clear).
- **Sol (Colloid):** Exhibits the

**Tyndall effect.** The particles are large enough to scatter light, making the path of a light beam visible. This is why a headlight beam is visible in fog (a colloid) or why a laser pointer can be seen through a glass of milk.

- **Suspension:** Can be **opaque** or scatter light, but the scattering is often due to the large, visible particles, not the subtle Tyndall effect typical of colloids. In many cases, they are simply too thick for light to pass through at all.

## Filtration: Can

## You Separate Them?

Different filter sizes are needed for each mixture.

- **Solution:** Cannot be separated by ordinary filtration. The particles are smaller than the pores of a standard filter paper. You would need a process like reverse osmosis or distillation.
- **Sol (Colloid):** Cannot be separated by ordinary filter paper. The particles are small enough to pass through. They can be separated by ultrafiltration or using a specialized membrane.

- **Suspension:** Can be easily separated by ordinary filtration. The large particles are trapped by the filter paper, leaving a clear liquid (the filtrate).

## REAL-WORLD EXAMPLES TO SOLIDIFY THE CONCEPT

Understanding the theory is one thing, but seeing these mixtures in everyday life makes the knowledge stick. Let us look at a few common examples.

# Kitchen Science: Mayonnaise vs.

## Oil and Vinegar

This is a perfect illustration. A simple mixture of oil and vinegar is a suspension. If you shake it, the oil droplets break up into various sizes. Let it sit, and they will quickly coalesce and separate into two layers. Now, think about mayonnaise. It is made from the same ingredients (oil, vinegar, and egg yolk), but it is a stable **sol** (or more specifically, an emulsion, which is a liquid-in-liquid colloid). The egg yolk acts as an emulsifier, breaking the oil into tiny particles (between 1 nm and 1000 nm) and preventing them from combining. It never separates at room temperature.

## Medicine: Cough Syrups and Injectable Drugs

The difference here is critical for safety and effectiveness. Many liquid oral medications are **suspensions**. The bottle instructs "shake well before use" because the active drug particles have settled. If you do not shake it, the first dose might be mostly water, and the last dose might be a dangerously concentrated slug of the drug. On the other hand, most injectable drugs are **solutions**. They must be perfectly homogeneous and free of any particles that could block a blood vessel. Colloidal

medicines, like certain vaccines or intravenous iron, are carefully designed **sols** where the active ingredient is dispersed in a stable, finely divided state for better absorption or to avoid anaphylactic shock.

## Nature: Rivers and the Ocean

When a river flows into the ocean, a fascinating chemical event occurs. The river water often carries clay particles as a **sol**. These particles are stabilized by the repulsive charges on their surfaces. When the river meets the saltwater of the ocean, the high concentration of charged ions (electrolytes) neutralizes the clay particles' charges. This causes

them to coagulate and form larger, visible flocs. The mixture changes from a stable **sol** (colloidal clay) to an unstable **suspension** (clay flocs), which then settle to form river deltas.
